

## PROFILES OF DIRECTORS AND SENIOR EXECUTIVES 董事及高級行政人員簡介

### EXECUTIVE DIRECTORS

**Mr. Thomas LAU, Luen-hung**, aged 49, is the Chairman and an Executive Director of the Company. Mr. Lau is also chairman and an executive director of The Kwong Sang Hong International Limited (“Kwong Sang Hong”), Chi Cheung Investment Company, Limited (“Chi Cheung”) and United Metals Holdings Limited, all of which are companies whose shares are listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). He has been with the Group since 1985 and has over 25 years of experience in corporate finance, manufacturing and property investment and development. Mr. Lau is the brother of Mr. Joseph Lau, Luen-hung.

**Mr. Joseph LAU, Luen-hung**, aged 51, is an Executive Director of the Company. Mr. Lau is also an executive director of Kwong Sang Hong and Chi Cheung, both companies are also listed on the Stock Exchange. He has over 27 years of experience in corporate finance, manufacturing and property investment and development. Mr. Lau is the brother of Mr. Thomas Lau, Luen-hung.
